ARTICLE 12 GENERAL GRAND CHAPTER MEDAL BRONZE FOR MERITORIOUS SERVICE

ONE COMPANION, A MEMBER OF THIS JURISDICTION, MAY BE SELECTED TO RECEIVE THIS AWARD EACH YEAR FOR MERITORIOUS SERVICE TO ROYAL ARCH MASONRY. THE COMMITTEE ON THE SELECTION OF A NOMINEE SHALL BE THE GRAND HIGH PRIEST, THE GRAND KING, THE GRAND SCRIBE, AND THE GRAND SECRETARY. NO GRAND CHAPTER OFFICER, OR PAST GRAND HIGH PRIEST SHALL BE ELIGIBLE TO RECEIVE THE AWARD. THE GENERAL GRAND HIGH PRIEST SHALL BE NOTIFIED OF THE SELECTION AT LEAST SIXTY (60) DAYS BEFORE THE PRESENTATION OF THE AWARD.
